**Explanation of Responses:**

On January 26, 2011, the reporting person was granted an option to purchase 331,275 shares of common stock, which vests in five equal annual installments based on the Company's satisfaction of certain performance criteria for each of the fiscal years ending December 31, 2011, 2012, 2013, 2014, and 2015. The performance criteria for 2014 were exceeded, resulting in the vesting of the option as to a total of 156,030 shares (66,255 shares relating to 2014 and, due to the application of the option's catch-up vesting provision, 66,255 shares relating to 2011 and 23,520 shares relating to 2012).
