**Explanation of Responses:**

- On February 21, 2012, the reporting person was granted an option to purchase 79,518 shares of common stock, which vests in four equal annual installments based on the Company's satisfaction of certain performance criteria for each of the fiscal years ending December 31, 2012, 2013, 2014, and 2015. The performance for 2015 were partially met, resulting in vesting of the option as to a total of 11,032 shares.
- On January 26, 2011, the reporting person was granted an option to purchase 82,815 shares of common stock, which vests in five equal annual installments based on the Company's satisfaction of certain performance criteria for each of the fiscal years ending December 31, 2011, 2012, 2013, 2014, and 2015. The performance for 2015 were partially met, resulting in vesting of the option as to a total of 7,426 shares.
